**“Delay condoned.**

**Issue notice.**

**There shall be interim stay of the impugned judgment and order dated 17<sup>th</sup> August, 2015, passed by the High Court of Orissa at Cuttack, in Writ Petition (C) No. 10161 of 2015.**

**We also restrain the petitioner herein to recover the sum from the respondent till the disposal of the present special leave petition.**

**Tag with S.L.P. (C) No. 28309 of 2015.”**
