A short issue arises for consideration with respect to addition of Sri Prasanna Venkatesa Perumal Temple, Mettupalayam, West Mambalam, Chennai for initiation of enquiry, though not a party to the proceedings before the High Court.

The learned counsel appearing for both sides submitted that the appellant has been wrongly included in the impugned order as it has got no connection with the *lis*.

In such view of the matter, paragraph 7 of the impugned order with respect to inclusion of the appellant Sri Prasanna Venkatesa Perumal Temple, Mettupalayam, West Mambalam, Chennai stand set aside.

The appeals are, accordingly, allowed.
