In case the petitioner is aggrieved, he/she is at liberty to question the same in appropriate proceedings before appropriate forum, since the order has been passed by the University considering the directions issued by this Court.

In view of the above, contempt proceedings are dropped and the notice is discharged. The Contempt Petition is disposed of.
