The matter above mentioned was listed before the Ld. Registrar Court on 13<sup>th</sup> July, 2015, when she was inter alia pleased to pass the following order:

Service of respondent nos. 6,7,9 to 11 and 13 is complete but none has entered appearance except for respondent no.6. Ld.
