The matter above mentioned was listed before the Hon'ble Court on 24.04.2015, when the Court was pleased to pass the following Order:-

**"Issue notice.**

**The respondents appearing on caveat are represented through their respective counsel.**

**Let notice be issued to the unrepresented respondents.**

**Counter affidavits be filed within four weeks. Rejoinder, if any, be filed within two weeks thereafter.**

**Any promotions made shall be made subject to the outcome of the present proceedings."**

It is submitted that as directed above, show cause notice to all the 31 respondents was issued on 09.05.2015 by regd. A.D. Ms. Sushma Suri, Mr. E. C. Agrawala and Ms. Vernika Tomar, Advocates have filed caveat/vakalatnama/appearance on behalf of respondent Nos. 1, 2, 3 to 18 and 19 to 25 and 28 to 31. Counsel appearing for Respondent Nos. 1-2 and 3 to 18 have filed Counter affidavit and the same have been placed with SLP Paper Books. Counsel for the petitioners has also filed Rejoinder Affidavits with the leave of Hon'ble Court and the same have been placed with SLP Paper Books. No one has entered appearance on behalf of respondent Nos. 26 and 27 though served with notice.
