SLP(C) Nos. 5027-5034/2023

Despite due service on respondent nos.3 and 6, there is no appearance.

Only Memo of Appearance filed by Mr. Akshay Amritanshu, Ld. Advocate in respect of respondent nos.1 and 2. Two weeks time, is granted to representing counsel to file vakalatnama as well as counter affidavit.

Ld. counsel for petitioner has failed to take fresh steps and furnish fresh particulars, for effecting service upon respondent nos.4 and 5.

Hence, process the matter for listing before the Hon'ble Judge-in-Chambers, for further directions.

SLP(C) No. 5008-5016/2023
