O R D E R

Permission to file SLPs( C) Dy No. 8975/2023 and Dy No. 8984/2023 is granted.

Delay condoned.

Abatement is set aside.

IA No. 54371/2023 - Application for substitution is allowed.

I.A. No. 54383/2023 for deletion of names of respondent Nos.192 to 201 in SLP (C) Dy.No. 8984/2023, I.A.No. 53760/2023 for deletion of names of respondent Nos. 8 to 58 in SLP (C) No. 5196/2023, I.A. No. 55080/2023 for deletion of names of respondent Nos. 8 to 45 in SLP (C)No.5251/2023 and I.A. No. 54786/2023 for deletion of names of respondent Nos. 8 to 47 in SLP (C) No. 5240/2023 are allowed.

Issue notice to the respondents.

The respondents may file their objections to these petitions.

In the meantime, there shall be stay of recovery from the salaries and benefits already paid to the petitioners and similarly placed employees. Further the pay-scale based on which salary is being paid as on today shall not be altered till further consideration is made in these petitions.

Though there is no impediment for the respondents to work out the modalities to implement the order passed by the High Court, the same shall not be given effect to in view of the earlier portion of this order.
