SLP(C) Nos. 4410-4433/2020

Mr. Amalpushp Shroti, Advocate for number of respondents filed counter affidavit alongwith IA for exemption from filing official translation. Said IA is defective. He failed to cure defects despite opportunities. Letter be issued in this regard.

Mr. M. E. Mazumdar, Advocate has filed only memo of appearance on behalf of respondent no. 5. He failed to file vakalatnama and counter affidavit despite opportunities.

However, as requested, learned counsel for petitioner to supply copy of petition to respondent no. 5 alongwith annexed documents within one weeks and file proof thereof. Thereafter, four weeks time, is granted to learned counsel to file vakalatnama and counter affidavit.
