SLP(C) No. 13867/2024

Sole respondent is granted four weeks' time as last opportunity for filing counter affidavit.

At the end of the period aforesaid, whether counter affidavit is filed or not, Registry to process the matter for listing before the Hon'ble Court as per rules.

SLP(C) No. 13841/2024

Vakalatnama has been filed on behalf of the sole respondent but the same is still defective. Defects be cured and counter affidavit be filed within four weeks as last opportunity.

At the end of the period aforesaid, whether counter affidavit is filed or not, Registry to process the matter for listing before the Hon'ble Court as per rules.

Service is complete on both the respondents but none has entered appearance.
