It is submitted for the information of the Hon'ble Court that the instant matters have been filed against the Judgment and Order dated 19.05.2016 and 01.12.2016 of the High Court of Delhi at New Delhi in C.M.A. NO. 10799 of 2016 with C.M.A. No. 11801 of 2016 in W.P. (C) No. 2212 of 2016 and C.M.A. No. 11501 of 2016 with C.M.A. No. 11503 of 2016 in WP (C) No. 2213 of 2016 and C.M.A. No. 11498 of 2016 with C.M.A. No. 11500 of 2016 in W.P. (C) No. 2214 of 2016 and WP (C) Nos. 2212, 2213 & 2214 of 2016. Matter filed against order dated 19.05.2016 is barred by time by 177 days and matter filed against order dated 01.12.2016 is within time. It is further submitted that Special Leave Petition(C) Nos. 7061 of 2017 between same parties arising out of similar issue is pending before the Hon'ble Court.

It is lastly submitted that counsel for the petitioner has on 21.03.2017 filed additional affidavit (Volume - 1 & 2) and same is being circulated herewith.

The Application in the matter above-mentioned is listed before the Hon'ble Court with this Office Report.
