The matter above mentioned were listed before the Hon'ble Court on 02.05.2016, when the Court was pleased to pass the following order :

SLP(C) Nos. 13396-13397 OF 2016

It is submitted that counsel for the petitioner has on 04.05.2016 filed spare copies of SLP to issue notice to all the 24 respondents. Therefore, notice was issued to all the 24 respondents on 06.05.2016 through Regd. A.D. post and Dasti in addition to the Counsel for the Petitioner on 05.05.2016 for effecting service on all the 24 Respondents. Counsel for the petitioner has not filed affidavit with proof of service of dasti notice upon all the 24 respondents so far.

Service of notice is awaited on all the respondents.

SLP(C) Nos. 13398-13420 OF 2016

It is submitted that counsel for the petitioner has on 03.05.2016 filed spare copies of SLP to issue notice to all the 4 respondents. Therefore, notice was issued to all the 4 respondents on 04.05.2016 through speed post and Dasti in addition to the Counsel for the Petitioner for effecting service on all the 4 Respondents. As per India post tracking report, notice have been delivered to Respondent Nos. 2 & 3 and notice on Respondent Nos. 1 & 4 have not delivered so far. Counsel for the petitioner has not filed affidavit with proof of service of dasti notice in respect of all the respondents so far.

Service of notice is complete on Respondent Nos. 2 & 3 as stated above, but no one has entered appearance on their behalf and service of notice is still awaited in respect of Respondent nos. 1 & 4.

It is further submitted that Respondent Nos. 4 to 24 in SLP(C) Nos. 13396-13397 of 2016 are petitioners in SLP(C) Nos. 13398-13420/16.(Main matter)
