All the above mentioned matters have been filed by the State of Odisha challenging the directions issued by the High Court for grant of benefit of RACP Scheme to the respondents-employees. The above referred diary numbers are of different departments viz (1) School &

Mass (Elementary Education); 2) Forest and Environment; 3) Health & Family welfare; 4) Social Security & Empowerment of Persons with Disabilities; 5) Higher Education; 6) Transport; 7) School & Mass (Secondary Education); 8) Agriculture; 9) Odisha Cooperation Department; 10) Finance; 11) Panchayati Raj; 12) Handloom & Textiles; 13) Water Resources etc.

The issues involved in all these cases regarding benefit of 1st, 2nd and 3rd RACP Scheme and grade pay. As per the Scheme, the benefit of grade pay is payable to the scales as specified or as per the grade pay of promotional post, so the rules of the different departments and O.R.S.P. Rules 1998, amended in 2008 are required to be examined. In the given situation, hearing of the cases, departments wise would be prudent for which the learned Advocates-on-Record appearing for the State Government have agreed to supply the batch of the cases, department-wise. They are required to prepare the list of the cases for tagging together. They are further requested to prepare a joint convenience compilation, which can be referred by both the parties at the time of hearing. The said compilation be prepared and filed after consulting the counsels appearing for the respondents in the connected matters.

Heard learned counsel for the parties.

Delay condoned.

Issue notice in the above matters as well as on all the fresh matters listed today, returnable in three weeks, in addition service through department is also permitted, and affidavit be filed in this regard.

Convenience compilation be also filed within the said period.

In some of the matters, it is indicated that caveat has been filed. Therefore, notice to the respondents appearing on caveat is waived.

It is informed that some matters have been filed in the Registry in which notices have not been issued. The lists of those cases have been furnished to the Court Masters, which will be forwarded to the Registry. The Registry shall list those matters on a Misc. Day at an early date, thereby hearing of all the case may be made analogously.
