O R D E R

SLP(C) No. 21142/2023

It has been submitted by Ld. counsel for respondent Nos.1 and 5 that counter affidavit has already been filed by the earlier Ld. counsel on behalf of the said respondents. Registry to verify and update the records.

Only Memo of appearance has been filed in respect of respondent Nos.2 to 4, however, no vakalatnama or counter affidavit has been filed on behalf of the said respondents, despite the grant of last opportunity.
