SLP(C) No.18044/2017

Being complete matter, place the same before the Hon'ble Court, as per rules.

Diary No. 17007/2017

The matter has already been directed to be listed before the Hon'ble Judge in Chambers. Therefore, no further orders are required to be passed in it.

Service of notice is complete qua respondent Nos. 3 and 4 but no one has entered appearance on their behalf.

Four weeks' time, as a last chance is given to respondent Nos. 1 and 2 to file the counter affidavit. After expiry of four weeks, the matter be processed for listing before the Hon'ble Court under the rules.

Hence, learned counsel for petitioner shall within a period of four weeks' file the fresh particulars of the said respondent and he shall also take requisite steps for the service of notice upon him.
