O R D E R

Ld. Counsel for the petitioner to take fresh steps to  
effect service on the unserved respondent in all the matters  
within two weeks time. Notices thereafter be issued.

Ld. Counsel appearing on behalf of Mr R.P. Goyal, Advocate-on-record submits that most of the respondents are Senior Citizens and the matter be processed for listing before the Hon'ble Court. Since many of the respondents in this batch are unserved, the matter cannot be listed before the Hon'ble court at this stage. However, the same will be listed before the Hon'ble Court on completion of service/pleadings.

All the represented respondents in all the matters are granted four weeks time for filing counter affidavit.

Vakalatnama filed by the ld. Counsel, Mr D.S.Chauhan is defective, since not related to the case.

Application for deletion of deceased respondent no.12 in D.No.17007/2017 has been filed but the same is found to be defective. Be cured within four weeks time. No application for substitution has been filed though vakalatnama on behalf of the proposed legal representatives has been filed.
