CIVIL APPEAL NOS. 1323-1344/2011

Despite last opportunity having been granted, the appellant has not furnished fresh address of sole respondent in CA Nos. 1326, 1344, 1338 and 1329 of 2011 and respondent no. 1 and 2 in CA No. 1335/2011 and both the respondents in CA No. 1339/2001.

As such, Registry to process the matter for listing before Hon'ble Judge-in-chamber.

CIVIL APPEAL NOS. 1359/2011

Despite last opportunity having been granted, the appellant has not taken fresh steps for service of respondent nos. 5, 10 and 12.

As such, Registry to process the matter for listing before Hon'ble Judge-in-chamber.

CIVIL APPEAL NOS. 1456/2012

Three weeks time, as last opportunity is granted for filing spare copy for service of respondent no. 67 and Notice be issued thereafter.

Await service of respondent nos. 54 and 55 from the Hon'ble High Court and reminder be issued to this effect.
