On perusal of the office report, the explanation as to why the money was not kept in the FDR is not found satisfactory. The attention of the Court at the relevant time should have been invited to the aspect and the money should not have been kept in this fashion. The responsibility will have to be fixed for it and the Registry will also find out whether in view of the fact that the money has been lying in the account for such a long period of time, any arrangement with the bank can be made out whereby some interest would be earned on this amount lying deposited for such a long period of time and along with interest if found admissible, the amount be kept in an FDR initially for a period of 91 days to be renewed till further orders or till the claimant(s) makes a claim on the amount.

Office report is ordered accordingly.
