The learned counsel appearing for the parties in Civil Appeal

No. 3361/2023 jointly state that the matter may be de-tagged from the present batch of matters.

The prayer is allowed. The appeal shall be listed in the week commencing 14.04.2025 before the Bench presided over by Hon'ble Mr. Justice P.S. Narasimha. The interim order will continue to operate till the next date of hearing.

Re-list all the other appeals/matters in the week commencing 14.04.2025.

In the meanwhile, the parties shall inform the Court as to whether there are any unsold inventories or unutilized Floor Area Ratio in the Earth Copia project situated in Gurugram, Haryana.

The directions issued above, it is clarified, will not be read as findings on the legal issues which arise for consideration.

I.A. No. 180402/2023 in Civil Appeal Nos. 2406-2407/2023

Issue notice to the Chairman of the Greater Noida Industrial Development Authority¹, who will file his personal affidavit stating as to how and why the lease was cancelled when the matter is pending before this Court and a status quo order was passed. Notice will be returnable in the week commencing 14.04.2025.

It will be open to the GNIDA to take recourse to appropriate steps.

The office report states that GNIDA has deposited costs of ₹5,00,000/- (Rupees five lakhs only), as imposed. The compliance affidavit has already been filed. The contents of the said
