 O R D E R

Office report indicates that number of  
 respondents are unserved in companion cases.

Considering the fact that the leading case

and some connected cases are ready and can proceed on the question of law, by way of indulgence, we give two weeks' time to the petitioner(s) to issue paper publication mentioning the returnable date of cases as 6<sup>th</sup> December, 2021. If the concerned respondents fail to appear on that date, the matter will proceed on the assumption that the service is complete on account of paper publication.

Further, no fresh matter be added to this group of cases, and even if added, those cases will stand de-linked or listed separately and would wait until the hearing of this batch of cases is complete.

The parties in such de-linked cases/fresh cases may be permitted to participate in the hearing in the leading case, if they so desire.

Accordingly, the petitioners may take necessary steps to serve the unserved respondents by dasti notice as well as by paper publication within two weeks from today. Notice through paper publication can be issued in two local newspapers one in English and other in vernacular language having wide circulation in the concerned area, mentioning the notified date of listing.

Affidavit of service be filed within two weeks.

We reiterate that if the concerned respondent(s) fail to appear on the date notified in the newspaper, the matter will proceed against such respondents *ex-parte* on the assumption that despite the deemed service that party has not chosen to appear in the proceedings.

List these matters on 6<sup>th</sup> December, 2021.
