- (i) Guidelines dated 11.09.2020;
- (ii) Notification dated 08.10.2020 issued pursuant to the guidelines;
- (iii) Worksheet on the basis of which aforesaid notification providing reservation has been issued; and
- (iv) Worksheet/data regarding the reservation pattern and rotation from 1994 onwards.

These documents be placed on record alongwith affidavit explaining the circumstances in which relaxation/modification has been done in cases, if any.

List these matters on 01.09.2021. SLP(C) Nos. 7492-7493/2021 be listed on that day as a separate item.
