It is submitted that Mr. Subhasish Bhowmick, Advocate has filed Special Leave Petition on 25.11.2016 against the Judgment and Order dated 08.04.2016 of the High Court of Punjab and Haryana at Chandigarh in RFA nos. 426 & 2695/2010 and 4351/2011 alongwith application for permission to file Special Leave Petition.

It is further submitted that Counsel for petitioner has also filed an application for substitution to bring on record the Lrs of deceased petitioner namely Jog Raj sole appellant in RFA no. 426/2010 and Sita appellant no. 3 in RFA no. 4351/2011 which is barred by time by 3375 & 4301 days respectively and Counsel has also filed an application for condonation of delay in filing

substitution application and setting aside abatement.

It is further submitted that Special Leave Petition filed against the Judgment and Order dated 08.04.2016 in RFA nos. 426 & 2695/2010 and 4351/2011 is barred by time by 92 days and Counsel for the petitioner has filed an application for condonation of delay in filing the SLP.

It is further submitted that SLP (C) No. 28564/2016 @ CC No. 15422/2016 Entitled GURDEV SINGH AND ORS vs STATE OF HARYANA AND ORS arising out of common order was listed before the Hon'ble Court on 19.09.2016, when the Hon'ble Court directed to issue of notice. SLP is pending after notice (Copy of order dated 19.09.2016 is enclosed herewith). (Main Matter SLP (C) No. 28906/2016.)
