This additional sum is acceptable to the claimants as submitted by Mr. Nanda Kumar K.B., learned counsel for the petitioners (claimants).

In view of above, the matters stand disposed of by directing the respondent - Insurance Company to deposit the additional sum of Rupees Five Lakhs And Fifty Thousand [in SLP (C) No(s).12602/2021] and Rupees Six Lakhs And Fifty Thousand [SLP(C) No.12603/2021] with the MACT, Ranebennur within four weeks from today. Thereafter, the deposited sum be released to the petitioners (claimants), by the Tribunal.

4. The matters stand disposed of in terms of the Award.

5. Court fee be refunded as per rules.
