**OFFICE REPORT**

The Special Leave Petition above-mentioned has been filed against the Judgment and order dated 29<sup>th</sup> December, 2016 of the High Court of Judicature at Hyderabad for the State of Telangana and the State of Andhra Pradesh in CMA No.364 of 2016.

It is also further submitted that CA No.2445 of 2014 referred to a Annexure P-4 was allowed by this Hon'ble Court on 18<sup>th</sup> February, 2014. (A copy of order dated 18<sup>th</sup> February, 2014 annexed as Annexure P-4 at Page Nos.96-98 of SLP paper-books)

It is lastly submitted that Counsel for the Petitioner has on 13<sup>th</sup> April, 2017 filed Additional documents alongwith an application to bring on record Additional Documents with the leave of the Hon'ble Court.
