O R D E R

1. We clarify that *status quo* order granted by this Court on 27.01.2023 will enure only to the benefit of those who had already been appointed and this order is in consonance with the Clause 14 of the Teachers Eligibility Qualifications in Medical Institutions Regulations, 2022.
2. In the meanwhile, Ms. Aishwarya Bhati, learned Additional Solicitor General shall take instructions on the scope and ambit of the Act, Rules and Regulations which operate in the issue involved.
3. Interlocutory applications for impleadment being IA Nos. 241597, 241591, 224568 and 241605 of 2024 are allowed. Cause-title be amended accordingly.
4. Parties are at liberty to file additional documents.
