O R D E R

D.No.11568/2019

Ld. Counsel for the petitioner submits that they intend to withdraw the defective application for substituted service and file a fresh application as they have been notified that respondent no.1059 has died. The submission is taken on record and time of two weeks is granted for doing the needful.
