**OFFICE REPORT**

The matter above mentioned was listed before the Hon'ble Court on 07<sup>th</sup> July, 2015, when the Court was pleased to pass the following order:

**“Delay condoned in filing the substitution application.  
The application for substitution to bring the legal  
representatives of deceased Petitioner No. 15 (Kashi Swain  
@ Kashi Nath) and deceased Petitioner No. 19 (Bamadba  
Swain) on record is allowed.  
Delay condoned in filing the special leave petition.  
Issue notice.  
In the meanwhile, the effect and operation of the impugned  
order shall remain stayed.”**

It is submitted for the information of the Ld. Registrar that in pursuance of the order quoted above, show cause notice was issued to all the seven respondents through registered A.D. post. A.D. cards duly signed have been received from Respondent Nos. 1, 3 and 5 but no one has entered appearance on their behalf so far. Neither A.D. cards nor unserved covers containing show cause notices have been received from Respondent Nos. 2, 4, 6 and 7 so far.

It is further submitted that we have received a letter from office of the Tahasildar, Deogarh, dated 13.08.2015 stated therein that as a Tahasil, Deogarh has divided into three Tahasils and after formation of new Tahasil, Barkote formed on 21.02.2009. The Tahasildar, Deogarh transferred and handed over all case records and relevant documents to the Tahsildar, Barkote. The land in question comes under the jurisdiction of the Tahasildar, Barkote. He requested that his name of the Tahasildar, Deogardh be deleted and Tahasildar, Barkote be inserted as Respondent No. 3.

Service of the show cause notice is not complete on Respondent Nos. 2, 4, 6 and 7.

The matter above mentioned is listed before the Hon'ble Court with this office report.
