Accordingly, we directed the special leave petition to be listed along with Civil Appeal No.364 of 2005. When that civil appeal was listed, prayer was made that certain transfer petitions are pending in this Court for transfer of cases from different High Courts to this Court to be heard along with Civil Appeal No.364 of 2005 as the point involved therein is same. In the transfer petitions, notices have been already issued. We feel that it is not necessary for the parties to pursue these transfer petitions further as we are in the midst of hearing Civil Appeal No.364 of 2005, but the proceedings in the cases, transfer of which has been sought for, should be stayed.
