**OFFICE REPORT**

The matter above-mentioned was listed before the Registrar's Court on 5<sup>th</sup> February, 2016, when the the following Order was passed :-

“The office report indicates that the Ld. Counsel for the respondent Nos.1 to 4 and 6 has failed to file the counter affidavit within the period stipulated under the rules.

The office report indicates that although by order dated 27.11.2015 of this Court four weeks time as last chance was given to the Learned Counsel for the petitioner to take fresh steps for the service of notice to the Respondent No.5(a) and 5(b), yet he has not done the needful within the period stipulated in the order.

Viewed in that context, the matter shall be processed for listing before the Hon'ble Judge in Chambers for further future directions.

Subsequently, The matter above-mentioned was listed before the Hon'ble Court (In Chamber) on 28<sup>th</sup> July, 2016, when the the following Order was passed :-

“Four weeks' time is granted to learned counsel for the petitioners for filing spare copies.”

It is submitted that accordingly fresh show cause notice was issued to Respondent Nos.5(a) & 5(b) through registered A.D Post on 14<sup>th</sup> September, 2016 Neither A.D card nor unserved cover containing show cause notice has been recieved back from the said Respondents as per tracking notice could not the served on Respondent Nos. 5(a) & 5(b).

It is further submitted that there are six Respondents in the matter. Ms. Anjani Aiyagiri, Advocate has filed Vakalatnama/Appearance on behalf of Respondent Nos. 1, 2, 3(a) to 3 (d), 4 & 6 but no counter affidavit has been filed so far.

Service is not complete on Respondent Nos. 5 (a) & 5(b)
