UPON hearing the counsel the Court made the following
O R D E R

In the facts and circumstances of the case and in view of the changed circumstances, more particularly when the COVID period has gone, we request the High Court to finally decide and dispose of the pending writ petitions rather than keeping them pending and issuing directions time to time, as early as possible. The High Court shall make all endeavours to finally decide and dispose of the pending writ petitions at the earliest and preferably within a period of three months from today. If any dispute arises on interpretation of any of the directions impugned in the present

Special Leave Petitions, the same may be agitated before the High and the High Court to consider the same in accordance with law and on its own merits.

Till the final disposal of the writ petitions, ad-interim relief granted earlier by this Court vide order dated 28.10.2020 is directed to be continued.

With this, all the Special Leave Petitions stand disposed of.
Pending application(s) shall stand disposed of.
