respondents in both the matters.

It is further submitted that Mr. Sanjay Kumar Visen,
Advocate has filed Vakalatnama and Memo of Appearance on
behalf of Respondent Nos. 1, 3 & 4 in SLP (C) No. 1132 of
2015 and Respondent Nos. 1 & 3 in SLP (C) No. 1133 of

2015 but no counter affidavit is filed on their behalf so far.

It is further submitted that AD Cards duly signed has been received back for common Respondent No 2 in both the matters and Respondent No. 4 in SLP (C) No. 1133 of 2015 but no one has entered appearance on their behalf.
