Endosulfan is significantly associated with Neurobehavioral disorders, Cognitive Hydrocephalus, Mental Retardation, Cognitive disorders, Cortical blindness, Seizure disorders, Parkinson's disease etc.

the Director ICMR and headed by General of the Commissioner (Agriculture) to conduct a scientific study on the question whether the use of Endosulfan would cause any serious health hazard to human beings and would cause environmental pollution. The Committee can also co-opt experts from the human field of environment as well as public health and also other allied areas. The Committee would submit its interim report within eight weeks from today and also would suggest any alternative to Endosulfan. Till the report is submitted, keeping in mind the various judgments of this Court under Article 21 of the Constitution of Ir particularly keeping in mind the precautionary India, particularly principle, we hereby pass an ad-interim order to immediate ban the production, use and sale of Endosulfan all over India and we further direct the statutory authorities to seize the permit given to Endosulfan till further the manufacturers of orders.
