Petitioner No. 6 in SLP(C) No.11416-17/2017 has expired. Ld. Counsel for the petitioner has filed an application seeking substitution along-with vakalatnama on behalf of the proposed lrs. but the same is defective. Four weeks' time, as last opportunity, is granted to Ld. Counsel for the petitioner to cure the defects. If defects are cured within the time granted, let the same be processed as per rules, else Registry to process the matter for listing before the Hon'ble Judge in Chambers for necessary directions.

Ld. Counsel for the petitioner has not cured the defects in the application seeking substitution of the lrs. of deceased petitioner No. 2 in SLP(C) No. 11388-389/2017 and deceased sole petitioner in SLP(C) No. 11412 & 11413/2017, despite the grant of last opportunity.
