UPON hearing the counsel, the Court made the following
O R D E R

W.P.(C) No.557/2020

Respondent nos. 8 and 11 have failed to file counter affidavit despite last opportunity having been granted, as such, further opportunity stands declined.

Service is complete on respondent nos 1 to 7,9,10 and 12 to 14 but none has entered appearance. However, Ld. counsel, Mr Devrat appearing on behalf of Ms Astha Sharma, Advocate-on-record appears for respondent no.14 and seeks time for filing vakalatnama and counter affidavit. Be filed within four weeks time.
