(Applicant In I.A. No. 6 ), it appears that CBI has indicated its views. It is open to the CBI to file a report in that regard before the concerned Court immediately. So far as the enquiry relating to others, it is stated that the opinion of the hand-writing expert and examination of some witnesses are necessary. We are told that the report is to be given by the Forensic Science Laboratory, New Delhi. The Director of the Laboratory shall ensure that the report is given as early as practicable but not later than two weeks. This order is being passed considering the urgency involved in the proceedings.

These cases shall be listed on 30th April, 2009. Before that date, a further up-to-date status report shall be submitted.

In the 2nd status report, it was indicated that the CBI wants to proceed against Ashutosh Asthana and others for commission of purported offences under the Prevention of Corruption Act, 1988. It is for the CBI to take necessary steps in that regard and no order is necessary from this Court.

Learned Solicitor General stated that a list of documents which CBI wants to get from the Allahabad High Court shall be submitted so that the same can be considered on the next date.

It is submitted that the bail applications of several persons are pending consideration before the High Court for a very long period. We request the Chief Justice of the Allahabad High Court to see that the bail applications are disposed of at an early date. We make
