O R D E R

1. Issue notice, returnable on 16.04.2024.
2. Mr. Nachiketa Joshi, AOR, Ms. Chitrangda Rastravara, AOR, Ms. Ankita Chaudhary, AOR and Mr. E. C. Agrawala, AOR accept notice on behalf of respondents.
3. Counter affidavit may be filed within four weeks. Rejoinder affidavit, if any, be filed within two weeks thereafter.
4. Records be requisitioned.
5. Subject to deposit of the compensation at the rate of Rs.10,000/- per sq. mt. with the Reference Court within a period of six weeks, the execution of the Reference Court award dated 05.03.2022, which includes the grant of interest from 1991, as upheld by the High Court vide impugned judgment dated 25.01.2024, shall remain stayed.
6. The claim regarding release of interim solatium and interest shall be determined on the next date of hearing.
