SLP (C) No. 27184/2015(Total 3 respondents)

It is submitted that Mr. Devesh Kumar Tripathi, Advocate for respondent Nos. 1 and 2 has not filed Counter Affidavit on their behalf so far.

It is further submitted that no one has entered appearance on behalf of respondent no. 3 so far.

Service of show cause notice is complete.

SLP (C) No. 27460/2015(Total 8 respondents)

It is submitted that no one has filed Vakalatnama and Memo of Appearance on behalf of respondent Nos. 1, 3 and 5-7 so far.

It is submitted that Ms. Rachna Joshi Issar, Advocate for petitioner has not filed Affidavit of Dasti service in respect of respondent Nos. 2, 4 and 8 so far.

Service of show cause notice is not complete on 2, 4 and 8.

No one has entered appearance on behalf of Respondent nos 81 so far.

Service of show cause notice is not complete on Respondent nos. 24, 33, 42, 45 & 67.

SLP (C) No. 27535/2015(Total 7 respondents)

It is submitted that Mr. Devesh Kumar Tripathi, Advocate has not filed Counter Affidavit on behalf of respondent Nos. 1 and 3 so far. Mr. U.S. Prasad, Advocate has filed Counter Affidavit on behalf of respondent No. 2. No one has entered appearance on behalf of respondent nos. 4 to 7 so far.

Service of show cause notice is complete.

SLP (C) No. 27676/2015(Total 33 respondents)

It is submitted that Mr. Devesh Kumar Tripathi, Advocate counsel for respondent Nos. 1 to 25, 27 to 30 has not filed Counter Affidavit on their behalf so far. No one has entered appearance on behalf of respondent nos. 26, 31-33 so far.

Service of show cause notice is complete.
