O R D E R

W.P. (C) No. 804/2018

Respondent nos. 1 and 5 have failed to file counter affidavit despite last opportunity having been granted, as such, further opportunity is declined.

W.P. (C) No.778/2018

Respondent no.4 has failed to file counter affidavit despite last opportunity having been granted, as such, further opportunity is declined.

W.P. (C) No.1149/2018

Respondent nos.2 and 3 are granted four weeks time for filing counter affidavit.

Service is complete on respondent nos. 1 and 4 but none has entered appearance.

W.P. (C) No.1167/2018

Respondent nos.1 and 3 are granted four weeks time for filing counter affidavit.

Service is complete on respondent no.2 but none has entered appearance.

W.P. (C) No.1134/2018

Service is complete on respondent no.1.
