**OFFICE REPORT**

The office report was listed before Ld. Registrar's Court on 29<sup>th</sup> October, 2015, when the following order was passed:-

Be provided within three weeks. Notice thereafter be issued.

Service is complete qua all the three respondents in SLP(C) No. 17215/2014, qua both the respondents in SLP(C) No. 18585/2014 qua respondent No. 1 in SLP(C) No. 18595/2014, qua respondent Nos. 1, 2, 5, 6, 11, 13, 15 to 19, 21 to 24, 27, 28, 31, 32, 34, 35, 36, 39, 42, 45, 49, 50, 51, 53, 54 to 57, 60, 66 and 71 in SLP(C) No. 22916/2014, qua respondent Nos. 1 to 25, 27 and 29 to 37 in SLP(C) No. 24966/2014 and qua respondent Nos. 2, 3, 7, 9, 14, 16, 18 and 19 in SLP(C) No. 12277/2014 and qua sole respondent in SLP(C) No. 20042/2014 is complete but none has entered appearance.

Opportunity for the sole respondent in SLP(C) No. 19776/2014 to file the counter affidavit has already been declined.

**SLP(C) No. 12274 of 2014**

It is submitted that show cause notice was issued on 14<sup>th</sup> December, 2015 to unserved respondent nos. 1 & 2 by registered A.D. post. Neither A.D. card nor unserved cover containing the notice has been received back from the said respondents so far.

**SLP(C) No. 12275 of 2014**

It is submitted that show cause notice was issued on 15<sup>th</sup> December, 2015 to unserved sole respondent by registered A.D. post. Neither A.D. card nor unserved cover containing the notice has been received back from the said respondent so far.

**SLP (C)No. 17215 of 2014**

It is submitted that A.D. Cards duly signed have been received back from all the three respondents but no one has filed Vakalatnama/Appearance on behalf of the said respondents so far. Service of notice is complete.

**SLP(C) NOS.18585 of 2014**

It is submitted that show cause notice was issued on 15<sup>th</sup> December, 2015 to unserved respondent no. 2 by registered A.D. post. Neither A.D. card nor unserved cover containing the notice has been received back from the said respondent so far.

It is further submitted that A.D. Card duly signed has been received back from respondent No. 1 but no one has Vakalatnama/Appearance on behalf of the said respondent No. 1 so far.

**SLP(C) NO. 20042 OF 2014**

It is submitted that A.D. Card duly signed and stamped has been received back from the sole respondent but no one has filed Vakalatnama/Appearance on behalf of sole respondent so far.

**SLP(C) NO.22916 OF 2014**

It is submitted that there are 71 respondents in this matter. It is further submitted that A.D. Cards duly signed have been received back from respondent Nos. 1, 2, 5, 6, 7, 9, 11, 13, 14, 15 to 19, 21 to 24, 27, 28, 31, 32, 34, 35, 36, 38, 39, 41, 42, 45, 49, 50, 51, 53, 54 to 57, 60, 66, 67 and 71 but no one has filed Vakalatnama/Appearance on behalf of said respondents so far.

**SLP(C) NO.24966 OF 2014**

It is submitted that there are 37 respondents in this matter. The counsel for the petitioner has not filed an application for substituting the legal representatives on record in respect of deceased respondent Nos. 26 and 28 so far.

It is further submitted that no one has filed Vakalatnama/Appearance on behalf of respondent Nos. 1 to 25, 27 and 29 to 37 though served with notice.

**SLP(C) NO. 12277 OF 2014**

It is submitted that there are 19 respondents in this matter. Show cause notice was issued on 15<sup>th</sup> December, 2015 to unserved respondent no. 17. Neither A.D. card nor unserved cover containing the notice has been received back from the said respondent so far.

It is lastly submitted that no one has filed vakalatnama/appearance on behalf of Respondent Nos. 2, 3, 7, 9, 14, 16, 18 and 19 though served with notice.
