Shri Raju Ramchandran, learned Senior Counsel appearing for the petitioner has drawn the attention of the Court to the affidavit filed in compliance of the order of the Court dated 8th May, 2017 indicating tentatively the schedule of payment which primarily is contingent on an additional loan being provided by the lender banks. As the remaining banks including Reserve Bank of India, Bank of Baroda are not present we request the learned counsels for the respondents Nos. 2 and 6 to communicate the proposal of the petitioner, as stated above, and incorporated in the additional affidavit, to the Joint Lenders Forum to obtain the response of the said Forum and place the same before the Court.
