These are the appeals by Special Leave Petition granted by this Court on 11<sup>th</sup> May, 2016 against the final Judgment and Order dated 30<sup>th</sup> December, 2015 in SWP No. 515/1997, SWP NO. 885/1997 and SWP No. 849 of 2011 passed by the High Court of Jammu and Kashmir at Jammu.

There are 2 respondents in Civil Appeal No. 5339 of 2016, 7 respondents in Civil Appeal No. 5340 of 2016 and 3 respondents in Civil Appeal No. 5341 of 2016 respectively.

It is submitted that Respondent No. 1 in Civil Appeal Nos. 5339 and 5341 of 2016 are represented by Mr. Ashok Mathur, Advocate and he has on 22<sup>nd</sup> September, 2016 filed Counter Affidavit on their behalf after serving its copy on the other side. Copy of the same has been included in the paper books.

It is further submitted that service report has been received from High Court of Jammu and Kashmir stating therein that notice has been served upon Respondent No. 7 in Civil Appeal No. 5340 of 2016 and that Respondent No. 2 in Civil Appeal No. 5339 of 2016 has been transferred, Respondent Nos. 1-4 in Civil Appeal No. 5340 of 2016 and Respondent Nos. 2-3 in Civil Appeal No. 5341 of 2016 are not working and lastly Respondent No. 6 in Civil Appeal No. 5340 of 2016 has retired and expired.
