Four weeks time, as last chance, is given to the learned counsel for the petitioners to comply with the terms of the order dated 04.08.2016 of this Court in respect of respondent no. 29.

SLP(C) No. 15416/2016

Fresh steps for the service of notice to the unserved respondents shall be taken by the learned counsel for the petitioners within a period of four weeks.

SLP(C) No. 26723/2016

SLP(C) No. 13531/2016:-

It is submitted that counsel for the petitioner has neither filed fresh particulars nor taken fresh steps for service of notice on respondent No. 29. No one has entered appearance on behalf of respondent Nos. 2, 3, 5, 6, 9, 10, 13, 18-20, 24, 28, 33, 34, 36, 38, 39, 42 & 44 so far. Neither A.D. card nor unserved cover containing notice has been received from respondent Nos. 1, 4, 7, 8, 11, 12, 14-17, 21-23, 25-27, 29-32, 35, 37, 40, 41 and 43.

Service is not complete.

SLP(C) No. 15416/2016:-

It is submitted that counsel for the petitioner has not taken fresh steps for the service of notice to the unserved respondents so far.

Service is not complete.

SLP(C) No. 26723/2016:-

It is submitted that counsel for the petitioner has neither furnished the fresh particulars of both the respondents nor filed spare copies for issuance of fresh notice to both the respondents.

Service is not complete on Respondent Nos. 1 & 2.
