There is a great scope for misusing of this notification as it may lead to illegal mining and top soil erosion causing enormous damage to the environment. We say no

more than request the Tribunal to examine this in close scrutiny.

- 5. Civil Appeals are disposed of with these observations.
- 6. We make it clear that we are not expressing any opinion in the matters.
- 7. Pending application(s), if any, stand disposed of.
