The matter above mentioned was Listed before the Hon'ble Court on 10/05/2016 alongwith SLP (C) NO. 11877 of 2016

when the Court was pleased to pass the

following Order: -

"Salary must be paid by the State Government to all the teachers/employees including the impleading applicants till the end of July, 2016.

List the matter in the first week of August, 2016."

It is submitted that Mr. Chanchal Kr. Ganguli, Advocate has on 19/07/2016 filed Contempt Petition for Non-compliance of this Court's order dated 10/05/2016 and has on 28/07/2016 filed a letter for withdrawn of this Contempt Petition. Hence the unregistered Contempt Petition is being circulated before the Hon'ble Court.

Mr. Chanchal Kumar Ganguli, Advocate has on 22/07/2016 filed two separate application for impleadment as party respondent alongwith Vakalatnama & Memo of appearance of the impleading parties. The application is registered as I.A. Nos. 3 & 4 and being circulated before the Hon'ble court.

Mr. Chanchal Kumar Ganguli, Advocate has on 22/07/2016 filed two separate application for modification of this Court's order dated 14/03/2016. Since the applications for impleadment filed by him are still not allowed by the Hon'ble Court, the unregistered application for modification are being circulated before the Hon'ble court.

Mr. Zoheb Hossain, Advocate has on 26/07/2016 filed application for direction on behalf of Respondent No. 7 alongwith 'No objection' obtained from Mr. Parijat Sinha, Advocate who was Advocate for the Respondent Nos. 7 to 10. The application is registered as I.A. No. 5 and being circulated before the Hon'ble court.

Mr. Kunal Chatterji, Advocate has on 25/07/2016 filed two separate applications for impleadment as party respondent

alongwith Vakalatnama & Memo of appearance of the impleading parties. The application is registered as I.A. Nos. 6 & 7 and being circulated before the Hon'ble court.

Mr. Kunal Chatterji, Advocate has on 25/07/2016 filed two separate applications for directions of this Court's order dated 14/03/2016. Since the applications for impleadment filed by him are still not allowed by the Hon'ble Court, the unregistered application for directions are being circulated before the Hon'ble court.

Mr. Chanchal Kumar Ganguli, Advocate has on 28/07/2016 filed application for impleadment as party respondent alongwith Vakalatnama & Memo of appearance of the impleading parties. The application is registered as I.A. No. 8 and being circulated before the Hon'ble court.

Ms. Anita Kanungo, Advocate has on 20/07/2016 filed Vakalatnama & Memo of appearance on behalf of Respondent Nos. 11, 12, 13, 14, 15, 17, 18, 20, 21, 22, 23, 24 & 26 but she has not filed Counter-affidavit, so far.

Neither AD cards nor unserved registered covers containing notice have been received back from the Respondent Nos. 3 to 6, 16, 19 & 25, so far. Counsel for the Petitioner has also not filed affidavit of dasti service in respect of Respondent Nos. 3 to 6, 16, 19 & 25, so far.
