UPON hearing the counsel the Court made the following
 O R D E R

Mr. Tushar Mehta, learned SG has stated that the main matter relating to PMLA has been finally heard by a Special Bench of three Judges in which hearing has been concluded and judgment reserved. Learned SG also stated that the question involved in this petition is included in the matter in which judgment has been reserved. He also states that a request has been made to the Registry of this Court for placing the matter before the Hon'ble Chief Justice of India for passing suitable order on the administrative side.

M/s. Mukul Rohatgi and Siddharth Luthra, learned senior counsel appearing for the petitioners oppose the prayer to list this petition before the Special Bench. However, since the question of listing has already been taken up with the Registry of this Court and in the similar matters where identical question is

involved has been finally heard and judgment has been reserved, we are not inclined to pass any order in this matter on merits.

Let the respondent/Union of India pursue the matter before the Registry.

List after appropriate orders are passed by the Hon'ble the Chief Justice of India.

The undertaking given by the respondents recorded in order dated 21.03.2022 shall continue to operate till the next date.
