Mr. Nageswara Rao has drawn our attention to the fact that subsequent to the impugned order passed by the High Court a contempt case, bearing CC No.1471 of 2013, has been filed by the respondent herein and the officers of the appellant Corporation are required to attend the Court. In view thereof Mr. Rao seeks stay of the contempt proceedings initiated by the respondent. Since the matter is under consideration in this Court, delay is condoned and notice is directed to be issued.

That being so, delay is condoned and notice is directed to be issued in all these matters.

In the meanwhile and until further order, there

will be an interim order of stay in terms of prayer clause 8(a) of the SLPs.

Accordingly, show cause notice is being issued to all the Respondents in SLP(C) No. 7807, 7808, 7809, 7810, and 7811 of 2014 and service of the same is awaited.
