O R D E R

SLP(C) Nos.8833-8841/2021

Last opportunity is granted to Ld. Counsel for the petitioner to take appropriate steps within four weeks with regard to deceased Respondent no.1 in SLP (c) Nos.8833 and 8834/2021.

Respondent no.2 in SLP (C) Nos.8833-8841/2021 has been deleted vide Hon'ble Judge in Chamber's order dated 08.12.2023.

Service is complete on Respondent no.1 in SLP (c) Nos.8835-8841/2021 and common respondent nos.4 and 5 in SLP (c) Nos.8833-8841/2021, still none has entered appearance.

Four weeks time, as a last opportunity, is granted to common respondent no.3 in SLP (c) Nos.8833-8841/2021 to file counter affidavit.
