UPON hearing counsel the Court made the following
O R D E R

Issue notice in S.L.P. (C) Nos.31288-31290 of 2011,
S.L.P. (C) Nos.32129-32131 of 2011 and S.L.P. (C) No.32636
of 2011, and let all the said matters be heard together.

In S.L.P. (C) Nos.31288-31290 of 2011, service of
notice on the respondent Nos.4, 11 and 12, is dispensed
with. Let it also be recorded that respondent Nos.2 and 3,
have died during the pendency of the matter before the High
Court. Their names, therefore, be expunged from the cause
title. The remaining respondent Nos.1 and 5 to 10, be
served, both in the usual course and also by way of Dasti
service.

As far as S.L.P. (C) Nos.32129-32131 of 2011, is
concerned, service of notice on the respondent Nos.1, 11 and
12, is dispensed with. Let it also be recorded that
respondent Nos.2 and 3 have expired during the pendency of
the matter before the High Court. Their names, therefore,
be expunged from the cause title. Let the respondent Nos.4
to 10 be served, both in the usual course and also by way of
Dasti service.

As far as S.L.P. (C) No.32636 of 2011, is concerned,
service on the respondent Nos.1, 2 and 4, is dispensed with.
Let the respondent No.3 be served, both in the usual course
and also by way of Dasti service.

The notices are made returnable six weeks hence.

The respondents will be entitled to file their
respective counter affidavits to the special leave petitions
within four weeks. Rejoinder thereto, if any, may be filed
within two weeks thereafter.
