O R D E R

IA's for impleadment in SLP(C) No.16745/2017, substitution of the deceased respondent No.29 in SLP(C) No.16948-79/2017, substitution of the deceased respondent No.30 in SLP(C) No.22580-82/2017 be processed as per rules for listing before the Hon'ble Judge in Chambers.

Respondent No.84 in SLP(C) D16710/2017 has expired. Relinquishment deed in favour of respondent No.86 has been filed but appropriate steps have not been taken. Four weeks' time is granted for the same.
