**SLP(c) No.1724/2017**

It is submitted that as directed above, show cause notice to all the 4 respondent was issued on 20.01.2017 by registered AD. M/s Saharya & Co., Advocate has on 28.02.2017 filed vakalatnama/appearance on behalf of respondent No. 4 but has not filed counter affidavit so far. As per tracking report of India Post notice has been delivered to respondent No. 1 but no one has entered appearance so far and tracking report of notice is not conclusive in respect of respondent Nos. 2 & 3.

Service is not complete on Respondent Nos. 2 & 3.

**SLP(c) No.1726/2017**

It is submitted that as directed above, show cause notice to all the 5 respondent was issued on 21.01.2017 by registered AD. Mr. Manish K. Bishnoi, Advocate has on 15.02.2017 filed vakalatnama/appearance on behalf of respondent No. 1 but has not filed counter affidavit so far. Mr. Garima Prasad, Advocate has filed vakalatnama/appearance as on behalf of respondent no. 2 but has not filed counter affidavit so far. As per tracking report, delivery of notice to respondent No. 1 is not conclusive.
