Learned counsel for the parties are at *ad idem* on the issue of compensation qua the land of the appellants being covered by the decisions of this Court dated 19<sup>th</sup> February, 2013 in Civil Appeal No.2187 of 2013 (Subhash Chander & Ors. vs. State of Haryana & Ors.) and dated 31<sup>st</sup> July, 2014 in Civil Appeal No.7657/2012 (Ranjit Singh & Anr.
